

VALLEY COUNTY BOARD OF SUPERVISORS' MINUTES

The Valley County Board of Supervisors met in regular session at 9:00 a.m., Monday, June 30, 2025, in the Courthouse Boardroom. Pledge of Allegiance recited, roll call taken: VanSlyke, Ference, Baker, Magiera, Petska, DeRiso, Stunkel present. Clerk verified meeting notice published; agenda posted. The Minutes of June 24, 2025, were approved on motion of DeRiso, second Stunkel. Carried. Yes: DeRiso, Stunkel, VanSlyke, Ference, Baker, Magiera, Petska. No: none. Absent: none. Baker moved to adopt the agenda with the correction of reading **Monday**, June 30, 2025, second Magiera. Carried. Yes: Stunkel, VanSlyke, Ference, Baker, Magiera, Petska, DeRiso. No: none. Absent: none. Open Meetings Act posted on the west wall; public copies available on the counter. Jake Bredthauer appeared and gave public comment about problem with the sheriff. Bredthauer provided handouts to the board and requested to appear on the next meeting's agenda. Bredthauer posed the question of who is liable for the action of the sheriff against him. The principle of limited government was discussed. No action was taken.

Projected ending budget balances were reviewed. Within the general fund, the county board, election, jail, and noxious weed budgets were exceeded. Overall, the general fund was under budget. Motion by DeRiso to approve Resolution 25-07 to authorize the transfer of funds and budget authority within the general fund to offset over expenditures in the county board, election, jail, and noxious weed budgets, second Ference. Carried. Yes: VanSlyke, Ference, Baker, Magiera, Petska, DeRiso, Stunkel. No: none. Absent: none. Discussion of issuing claims for budget shortages and the inheritance fund occurred. Chuck Abel appeared to discuss options and the new budget legislation.

The board took a short break at 9:55am and reconvened at 10:05am.

Motion by Stunkel to set sheriff and jail employees pay period to a 28 day period with 171 working hours before overtime eligibility, second Ference. Carried. Yes: Ference, Baker, Magiera, Petska, DeRiso, Stunkel, VanSlyke. No: none. Absent: none.

An Amended Interlocal Law Enforcement Agreement with the City of Ord was reviewed and discussed. Also discussed were the current interlocal law enforcement agreements with Arcadia and North Loup. Motion by Stunkel to approve and sign amended interlocal law enforcement agreement with the City of Ord, second Ference. Yes: Baker, Magiera, Petska, Stunkel, VanSlyke, Ference. No: DeRiso. Absent: none.

Motion by Stunkel to enter executive session at 10:20am, second Magiera. Carried. Yes: Magiera, Petska, DeRiso, Stunkel, VanSlyke, Ference, Baker. No: none. Absent: none. The board exited executive session at 10:49am with no action taken.

The meeting adjourned at 10:53am, to reconvene on July 8, 2025, at 9:00am in regular session and at 9:30am as board of equalization.
