The Valley County Board of Supervisors met in regular session at 9:00am, Tuesday, September 9, 2025, in the Courthouse Boardroom. Pledge of Allegiance recited, roll call taken: VanSlyke, Ference, Baker, Magiera, Petska, DeRiso, Stunkel present. Absent: none. Clerk verified meeting notice published; agenda posted. The Minutes of August 26, 2025, were approved on motion of Baker, second Stunkel. Carried. Yes: Petska, DeRiso, Stunkel, VanSlyke, Ference, Baker, Magiera. No: none. Absent: none. Magiera moved to adopt the agenda, second DeRiso. Carried. Yes: DeRiso, Stunkel, VanSlyke, Ference, Baker, Magiera, Petska. No: none. Absent: none. Open Meetings Act posted on the west wall, public copies available on the counter. No public comment.

Road Superintendent Jay Meyer appeared and gave report on overlay on Sargent-Ord Road, fixing roads after recent heavy rains, and tree contractors coming soon. County Attorney Brandon Hanson gave report on no jury trials set for September, uptick in juvenile cases.

Motion by Ference to enter executive session for personnel reasons at 9:47am, second Stunkel. Carried. All voting yes. The board exited executive session at 10:03am with no decisions made. Magiera left the meeting at 10:03am.

The board took a short break at 10:09am and reconvened at 10:19am with Magiera absent. Treasurer Peggy Brott gave report on month end fund report, fund balance listing, to include balances as of August 31, 2025, for general fund \$827,492.83, road fund \$183,005.10, and inheritance

fund \$1,331,418.69, miscellaneous receipts, month end balance sheet, and pledge securities.

The August District and County Courts Fees and Fines Reports were reviewed.

Annual subscription renewal with Tyler Technologies for Veterans' Services was reviewed. Motion by Ference to approve the subscription renewal, second Stunkel. Carried. Yes: DeRiso, Stunkel, VanSlyke, Ference, Baker, Magiera, Petska. No: none. Absent: none.

Clerk KeShara Poland gave report on August Register of Deeds report. Acceptance of passport applications was discussed.

The budget for fiscal year 2025-2026 was reviewed. The Joint Public Hearing was further discussed.

The NACO Annual Conference will be held in Kearney on December 17-19, 2025, with registration opening September 10. Discussion on board members who would like to attend and if hotel rooms are needed. Clerk will handle registrations and reservations.
