The Valley County Board of Supervisors met in regular session at 9:00am, Tuesday, September 23, 2025, in the Courthouse Boardroom. Ference arrived at 9:02am. The Minutes of September 9, 2025, were approved on motion of Stunkel, second Baker. Carried. Yes: Stunkel, VanSlyke, Ference, Baker, Magiera, Petska. No: none.
