VALLEY COUNTY BOARD OF SUPERVISORS' MINUTES

The Valley County Board of Supervisors met in regular session at 9:00 a.m., Tuesday, March 14, 2017 in the Courthouse Boardroom. The Pledge of Allegiance was recited. Roll call: Baker, Cetak, Cullers, DeRiso, Sevenker, VanSlyke, Waldmann present. Clerk verified meeting notice published and agenda posted. VanSlyke indicated that the February 28 minutes should be amended to reflect that Weed Supt. Kaminski reported Method was not cleared for haying and grazing instead of Perspective. The corrected February 28 meeting minutes were approved on motion of DeRiso, second Cetak. Carried. Yes: Baker, Cullers, Waldmann, DeRiso, Cetak, Sevenker, VanSlyke. No: none. Absent: none. Cullers moved to adopt the agenda, second Waldmann. Carried. Yes: Cullers, Waldmann, DeRiso, Cetak, Sevenker, VanSlyke, Baker. No: none. Absent: none. Sevenker noted Open Meetings Act posted; public copies available. There was no public comment.

Road Supt. Meyer's General Report included: pushed snow; treated paved roads; bridge tore out south of Staab's, tubes back in; several items taken to consignment auction, proceeds will go to Treasurer; hauling gravel; maintaining roads; will be starting bridge on Round Barn Road, tubes arrived last week; cleaned ditches. Meyer will look at a culvert on the minimum maintenance road near Lutz's that was brought to his attention by VanSlyke.

Meyer reported on motor grader service program from Caterpillar, on basic tier, receive pre-packaged box for each machine, has everything needed to service and take oil samples, send samples to lab, report sent to County, next package is sent, do not need to stock multiple filters, 30% discount on filters and 25% discount on bulk oil. Price up \$13,000 from last year to upgrade motor graders, negotiated with Caterpillar so price will be same as last year, \$13,000 parts credit for each machine purchased, can reduce some budget items by using credit; should be room in budget for purchase of grader; tax asking should go down; roads in good shape.

Weed Supt. Kaminski was present for discussion on renewal of his contract and the annual resolution authorizing himself, the County Board and County Attorney to fulfill the duties of the office. VanSlyke asked that the Board get copies of the 10-Day Notices. Baker moved to approve the contract and Resolution 17-03, second VanSlyke. Carried. Yes: Waldmann, DeRiso, Cetak, Sevenker, VanSlyke, Baker, Cullers. No: none. Absent: none.

County Attorney Hansen joined the discussion of 811th Road. The Public Highway At-Grade Crossing Agreement was received from Union Pacific; County has to maintain crossing area, exempt from maintaining anything in railroad area; County responsible for temporary flagging materials during construction; railroad must see plans before construction; require \$2,000 fee be paid with contract; if lights are needed in the future County will have to pay for them. Road Supt. Meyer expressed his concern that the railroad has given no timeline for construction of the crossing or how long it will take them to approve the agreement; no criteria for when lights and gates needed at the crossing; does not know where Diamond Engineering is on their schedule to begin the concrete work. Cetak made a motion to approve the Public Highway At-Grade Crossing Agreement, second Baker. Motion not carried. Yes: Cetak, Sevenker, Waldmann. No: DeRiso, VanSlyke, Baker, Cullers. Absent: none. Meyer will contact the Public Service Commission concerning the Railroad. Tabled discussion of 811th road until March 28th meeting.

Linda Curry appeared to discuss the 18 cemeteries in the County that she has located; abandoned when no longer any association connected to the cemetery; County real estate records indicate dimensions of cemetery; Manderson, Vinton and Elyria cemeteries in most need of care; cemeteries need to be fenced, mowed and have an identifying sign. Road Dept. will clean-up the three cemeteries, 4-H Club will care for two cemeteries for pay and one as a volunteer project, County Atty. Hansen will review the statues concerning abandoned cemeteries.

In his General Report Hansen said that there will be more claims for autopsies and several trials are set for May 15.

Meeting recessed at 10:40 a.m. and reconvened at 10:50 a.m. with all members present.

Treasurer Suminski presented the Fund Balance Report, noting that the County is receiving Property Tax credits from the State. The following items regarding the tax sale were presented: the annual Certification closing the tax sale, list of taxes sold at tax sale, annual notice of delinquent taxes/assessments and a Resolution of Foreclosure. Suminski noted that 9 certificates were sold and that private sales can still be made, sold \$21,753.15, tax sale fees of \$180 were collected and registration fees of \$250. Misc. Receipts folder available for review. Resolution 17-4, directing the County Attorney to foreclose on delinquent real estate taxes, assessments, etc., was approved on motion

of Cullers, second Waldmann. Carried. Yes: Cetak, Sevenker, VanSlyke, Baker, Cullers, Waldmann, DeRiso. No: none. Absent: none.

The County Clerk and Clerk of the District Court February Fee Reports were reviewed.

The following informational items were reviewed: list of current surveys being conducted by County Surveyor, Central District Meeting March 16 in Kearney, Wozab meeting 7:00 p.m. March 27 to review applications.

Baker reported that he will check to see when the locksmith will be back.

Road Supt. Meyer returned to the meeting to report on his call to the Public Service Commission; do not have much to do with railroads any more, told to contact Nebraska Department of Roads. NDOR will review the Crossing Agreement; there is a formula to determine when lights are needed, upgrading crossing can cost \$750,000, safety funds are available for gates and lights, usually the county pays 5%, railroad 5% and State pays rest; NDOR recommends whether lights and gates are needed. Meyer will see where concrete work is on Diamond Engineering's schedule.

Following discussion to remove \$2,000 fee to Railroad from Fund Request, Cullers moved to approve March Claims and Fund Request in the amount of \$33,795.50, second Cetak. Carried. Yes: Sevenker, VanSlyke, Baker, Cullers, Waldmann, DeRiso, Cetak. No: none. Absent: none.

The term of Hospital Board member Michelle Zangger expires April 30, 2017. Sevenker noted that she is willing to continue to serve. Following discussion of how someone can apply to serve on the Hospital Board, Cullers moved to reappoint Zangger to another term, second Waldmann. Carried. Yes: VanSlyke, Baker, Cullers, Waldmann, DeRiso, Cetak, Sevenker. No: none. Absent: none. Baker made a motion to create a policy for applications for appointment to the Hospital Board, second Cullers. Carried. Yes: Baker, Cullers, Waldmann, DeRiso, VanSlyke. No: Cetak, Sevenker. Absent: none. County Atty. Hansen will be directed to create a policy for applying for the Hospital Board.

The Village of North Loup public hearing on the First Amendment to the 2015 Redevelopment Plan was reviewed. Julie Brooker, Central Nebraska Director of Constituent Services for Senator Deb Fischer, will be holding a local office in the Courthouse Lobby on March 28, 2017 from 10:00 a.m. to 11:00 a.m.

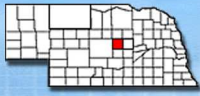
